

TOWN HOUSE® CRACKERS SPINACH CHEESE BITES



Ingredients:

- 2 tsp. olive oil
- 1/2 tsp. finely chopped or pressed garlic
- 1 bag (6 oz.) fresh baby spinach, coarsely chopped
- 1 1/2 tsp. dried Italian herb seasoning
- 1/4 tsp. salt
- 1 1/4 cup shredded fresh asiago, parmesan or pepper jack cheese
- 16 KEEBLER® Town House® Crackers

Preparation:

Preheat oven to 375°F. Heat olive oil in medium skillet over medium heat. Add garlic, spinach, Italian herb seasoning, and salt; stir and cook for 3-4 minutes or until spinach wilts. Remove from heat. Drain spinach and pat dry. Place into bowl and stir in cheese. Place crackers on baking sheet. Spoon about 1 1/2 teaspoons spinach mixture on each cracker. Bake for 5 minutes or until hot. Garnish as desired. Serve warm. Makes 16 servings (about 1/2 cup topping).

CLUB® CRACKERS QUICHES

Ingredients:

- KEEBLER® Club® Crackers
- 3/4 cup shredded cheddar cheese
- 6 slices crisp cooked bacon, crumbled
- 1/2 cup thinly sliced green onions
- 5 tsp. all purpose flour
- 6 large eggs
- 2 cups half and half (regular or fat-free,) or evaporated skim milk
- 1/2 tsp. salt
- 1/2 tsp. ground black pepper
- Garnish: fresh fruit and mint sprigs

Preparation:

Place baking sheet in oven and preheat to 350°F. Place 6 crackers in plastic bag; seal and crush into fine crumbs. Butter 6 ramekins. Sprinkle cracker crumbs on bottom and sides. In bowl stir cheese, bacon, green onions, and flour. Spoon mixture in ramekins. Crack eggs in bowl; lightly beat. Whisk in half and half and salt and pepper. Pour in ramekins over cheese mixture. Place ramekins on baking sheet in oven. Bake 30 minutes or until set in centers. Cool 5 minutes. Run knife around edges of ramekin. Invert on to individual plates. Fan crackers beside each quiche. Garnish as desired. Makes 6 servings.
